**Sub.: *Collection of data for finalization of ordinary members list for participation in the election of Representatives/Chairman for five Panels for the year 2020-21 by e-Voting.***

In terms of Para 2.92 of the Handbook of Procedure (2015-20) as well as subsequent letter No. 12/2/2013-E&MDA dated 7th December, 2015 issued by the Ministry of Commerce & Industry, Government of India, Electronic Voting would be mandatory for election to the posts of Executive Committee members with a view to ensuring wider participation.

The Competent Authority has decided to conduct election of the following five panels to elect the Panel Representatives (Chairmen) for the year 2020-21:

- 1) Books, Publications & Printing Panel,
- 2) Rubber Products Panel,
- 3) Paints, Printing Ink & Allied Products Panel,
- 4) Glass & Glassware Panel and
- 5) Manufactured Products of Carbon Graphite, Explosives and Accessories Panel.

As such, CAPEXIL intends to complete the election process by e-Voting for the aforesaid five panels to reconstitute the Committee of Administration of the Council for the year 2020-21 in stipulated time.

In terms of the Articles of Association of CAPEXIL, only Ordinary Members are eligible to participate in the election process. In terms of Clause no. 3.3 of Articles of Association of CAPEXIL, in order to be eligible for Ordinary Members of the Council, a person must satisfy the following requirements, namely:

(a) He, or the entity represented by him, must have been an Associate Member of the Council for at least three years.

(b) He, or the entity represented by him, must have, to his or its credit, during the three financial years immediately preceding (2017-18, 2018-19 and 2019-20) average exports in respect of the product, of not less than the amount mentioned below:

In terms of Clause no. 13 of Articles of Association of CAPEXIL read with Clause no. 11 and 12 of the Articles of Association of CAPEXIL, an ordinary members can stand as a candidate or cast their vote provided that they have already paid their upto-date membership subscription and they have no other outstanding or dues to the CAPEXIL by the 30th April of the year for which it has become due.

However, in view of OM F. No. J/8/2020-E&MDA-DoC dated 24<sup>th</sup> September, 2020, the Competent Authority has decided to take all members who have paid their membership fees for the F.Y. 2020-21 on or before 30<sup>th</sup> September, 2020 and followed other requisite criterion in finalising the list of Ordinary Members/ Voters for taking part in the Election process for the year 2020-21.

In terms of Clause no. 4.2 of Articles of Association of CAPEXIL, a candidate for election to any position in the Council must satisfy the following conditions, namely:

(a) He, or the entity represented by him, must have, to his or its credit, during the one financial year immediately preceding, exports of the products of not less than the amount mentioned below:

In view of the above, we have to finalize the list of ordinary members (publish "Electoral Rolls") to enable them to take part in the e-Voting. We therefore, request our bonafide members to furnish their export turnover of CAPEXIL's products for immediately three preceding financial years (i.e. for the F.Y. 2017-18, 2018-19 and 2019-20) as well as self-certified payment particulars of membership subscription etc. for the F.Y. 2019-20 and 2020-21 specifying cheque/DD No./online payment details, date and amount etc. Above details to be submitted online in ANNEX-1 by login at [https://members.capexil.org/member\\_home.php](https://members.capexil.org/member_home.php) by using registered email as User Id & IEC as Password on or before 16<sup>th</sup> November, 2020 (Monday). **Print copy of Online ANNEX-1 for Election 2020-21 duly certified by the Competent Authority of the member firm needs to be forwarded to data@capexil.in on or before 16<sup>th</sup> November, 2020 (Monday).**

**Please note that in the event of non-receipt of Annex-1 latest by 16<sup>th</sup> November, 2020, the Council will be compelled not to include their names in the Ordinary Members List / Voter List of the Council** and accordingly, they shall not be eligible to take part either in the election or to contest in the election process of the above mentioned five panels for the purpose of inclusion in the reconstitution of Committee of CAPEXIL for the year 2020-21.

Kindly treat this letter on PRIORITY and URGENT basis.
